ORDER:

In the Government Order second read above, the administrative setup of the Forest Department was reorganized and among other things, the following posts were placed under the administrative control of Coimbatore Circle:-

1.	District Forest Officer, Coimbatore Division, Coimbatore i. Assistant Conservator of Forests, Coimbatore Division. ii. Forestry Extension Officer, Coimbatore.
2.	District Forest Officer, Nilgiris Division, Udhagamandalam i. Assistant Conservator of Forests, Nilgiris Division, The Nilgiris

3.	District Forest Officer, Gudalur Division, Gudalur i. Assistant Conservator of Forests, Gudalur Division, Gudalur
4.	Assistant Conservator of Forests, Forest Protection Squad, Coimbatore

2. As per the orders issued in the Government order third read above, the following three senior duty posts sanctioned to Indian Forest Service of this State Cadre are now functioning in the level of Conservator of Forests:-

- i. Chief Conservator of Forests, Coimbatore Circle, Coimbatore
- ii. Chief Conservator of Forests & Field Director Anamalai Tiger Reserve, Pollachi
- iii. Chief Conservator of Forests & Field Director, Mudumalai Tiger Reserve.

3. The Principal Chief Conservator of Forests (Head of Department) in his letter fourth read above, to enhance the functional efficiency of the Circles and Divisions and to ease the present vacancies in the cadre of Indian Forest Service, has sent proposal for merging the Conservator of Forests, Coimbatore Circle, Coimbatore with Conservator of Forests and Field Director, Anamalai Tiger Reserve, Pollachi, with new head quarters at Coimbatore and for placing the posts now functioning under the control of Conservator of Forests, Coimbatore Circle, Coimbatore with the Conservator of Forests and Field Director, Anamalai Tiger Reserve, Coimbatore and the Conservator of Forests and Field Director, Mudumalai Tiger Reserve, Udhaigai, based on their jurisdiction, making certain other consequent administrative arrangements.

4. The Government after careful examination accept the proposal of the Principal Chief Conservator of Forests (Head of Department) and direct that the existing Conservator of Forests, Coimbatore Circle, Coimbatore be merged with the Conservator of Forests and Field Director, Anamalai Tiger Reserve, Pollachi and the Field Director, Anamalai Tiger Reserve shall function with new headquarters at Coimbatore. The Government also direct that the posts which are now functioning under the Conservator of Forests, Coimbatore Circle, be placed under the control of Conservator of Forests and Field Director, Anamalai Tiger Reserve, Coimbatore and


