ORDER:

In the Government Order second read above, the Virudhunagar Forest Circle was merged with Conservator of Forests and Field Director, Srivilliputhur Megamalai Tiger Reserve, Madurai with exclusion of Ramanathapuram Division and the Ramanathapuram Division was ordered to be administered by the Field Director, Kalakad Mundanthurai Tiger Reserve, Tirunelveli.

2. In the letters third read above the Principal Chief Conservator of Forests (Head of Department) has informed that there is dearth of hands in the level of Additional Principal Chief Conservator of Forests, Chief Conservator of Forests and Conservator of Forests and therefore it is found difficult to fill all these territorial Circle posts and to manage the Circles with available officers. The Principal Chief Conservator of Forests (Head of Department) has therefore requested merger of Thanjavur Circle with Trichy Circle to ease the vacancy position in the Circle level posts and to improve the efficiency of functioning of the Department.

3. The Government, after careful examination, accept the proposal of the Principal Chief Conservator of Forests (Head of Department) and direct that the existing Thanjavur Forest Circle, Thanjavur be merged with Trichy Forest Circle, Trichy.
