### ORDER:-

In the Government Order first read above, the Government have delegated the powers to the Conservator of Forests for sanction of the compensation to the victims attacked by the wild animals.

2. In the letter second read above, the Principal Chief Conservator of Forests and Chief Wildlife Warden has stated that due to long chain of correspondence, the delay occurs in disbursing the compensation to the affected parties. In order to effectively sanction the compensation immediately for each and every damage caused, he has requested to delegate the powers to the "Additional Principal Chief Conservator of Forests / Chief Conservator of Forests / Conservator of Forests of respective circle for sanction of the compensation in respect of Human death and Human Injury and to the District Forest Officers / Wildlife Wardens / Deputy Directors of respective divisions for sanction of the compensation in respect of Crop damages, Livestock damages, Property damages caused by Wildlife"

3. The Government after careful examination of the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden, delegate the powers to the "Additional Principal Chief Conservator of Forests / Chief Conservator of Forests of respective territorial circle for sanction of the compensation in respect of Human death and to the District Forest Officers / Wildlife Wardens / Deputy Directors of respective territorial division / wildlife division for sanction of the compensation in respect of Human Injury, Crop damages, Livestock damages and Property damages caused by Wildlife".
