ORDER:

In the Government order first read above orders have been issued permission for delegating the powers to the forest officials to write off of the deficit value of sandalwood due to dryage of sandalwood.

2) In the letter second read above, the Principal Chief Conservator of Forests has stated that the constant increase of average sandalwood sale price and considerable decrease in repel value was resulted in sustainable erosion of financial powers to write off of the deficit value of Sandalwood due to dryage. He has therefore requested the Government to enhance the financial powers delegated to the officials for the purpose of write off of the deficit value of Sandalwood due to dryage of sandalwood.

3) The Government, after careful examination, accept the proposal of the Principal Chief Conservator of Forests and enhance the financial powers to the

forest officials for the purpose of write off of the deficit value of sandal wood due to dryage as below:
