ORDER :

In the Government Order first read above, the Government upgraded the post of Managing Director, Arasu Rubber Corporation Limited, Nagercoil, Kanyakumari District, from the level of Chief Conservator of Forests to the level of Additional Principal Chief Conservator of Forests in the pre-revised scale of pay of Rs.22400-525-24500. The upgraded post of Managing Director, Arasu Rubber Corporation Limited in the rank of Additional Principal Chief Conservator of Forests was ordered equivalent in the status and responsibilities to the post of Additional Principal Chief Conservator of Forests under sub-rule (i) of rule 9 of the Indian Forest Service (Pay) Rules 1968.

2. In the Government Order second read above, among other things, it was ordered that the post of Managing Director, Arasu Rubber Corporation Limited in the rank of Additional Principal Chief Conservator of Forests shall be kept in abeyance and the post of Joint Managing Director in the Arasu Rubber Corporation which was in the level of Chief Conservator of Forests (Rs.37400-67000 + 10000 Grade Pay) was re-designated as Managing Director in the rank of Chief Conservator of Forests.

3. Now, in the circumstances reported by the Principal Chief Conservator of Forests (Head of Forest Force) in his letter third read above, the Government order that the existing post of Chief Conservator of Forests and Managing Director, Arasu Rubber Corporation Limited, Nagercoil, be upgraded to the level of Additional Principal Chief Conservator of Forests in the Level 15 in the Pay Matrix of Indian Forest Service (Pay) Rules,2016 (Rs.182200-224100).

Under rule 12(1) of the Indian Forest Service (Pay) Rules, 2016, the Government declare that the post upgraded in para 3 above, be equivalent in status and responsibilities to the cadre post of Additional Principal Chief Conservator of Forests (Level-15), specified in Schedule-II- Part A of the Indian Forest Service (Pay) Rules, 2016.

5. This order issues with the concurrence of Finance Department vide its U.O. No.2431/FS/P/2020, dated.22.07.2020.
