ORDER:

Sanction is hereby accorded for creation of one post at the level of Principal Chief Conservator of Forests namely; Principal Chief Conservator of Forests (Forest Conservation Act), Chennai, under Rule 4(2) of the Indian Forest Service (Cadre) Rules, 1966, in the Higher Administrative Grade of Indian Forest Service [Level 16 in the Pay Matrix (Rs.205400-224400)], for a period of one year with effect from the date of appointment, (or) till the incumbent vacate the post, by keeping in abeyance of the cadre post of Additional Principal Chief Conservator of Forests (Forest Conservation Act), Chennai.

2. The following transfer and postings at the level of Principal Chief Conservator of Forests is notified:-

Thiru Inder Dhamija, IFS., (TN: 1985), Principal Chief Conservator of Forests (on Compulsory wait) on his reversion from Central deputation with Government of India, Ministry of Youth Affairs and Sports is posted as Principal Chief Conservator of Forests (Forest Conservation Act), Chennai, in the newly created post at para 1 above.

Under rule 12(1) of the Indian Forest Service (Pay) Rules, 2016, the Government declare that the post of Principal Chief Conservator of Forests in the Higher Administrative Grade of Indian Forest Service created in para 1 above, be equivalent in status and responsibilities to the cadre post of 'Principal Chief Conservator of Forests (Level-16)' specified in Schedule-II- Part A of the Indian Forest Service (Pay) Rules, 2016.
