ORDER:

The Hon'ble Chief Minister has made the following announcement on the floor of the Legislative Assembly on 01.06.2018, under Rule 110:-

“தற்போது வனத்துறை தலைமை அலுவலகம் பனகல் மாளிகையில் செயல்பட்டு வருகிறது. அங்குள்ள இடப்பற்றாக குறையை கருத்தில் கொண்டு, வேளச்சேரியில் அமைந்துள்ள வனத்துறைக்கு சொந்தமான இடத்தில் வனத்துறை தலைமை அலுவலகக் கட்டடம் 70,000 சதுர அடி பரப்பளவு கொண்ட இரு தொகுதி கட்டடங்களாக 30 கோடி ரூபாய் செலவில் கட்டப்படும்”.

2. In the letter read above, the Principal Chief Conservator of Forests has stated that the proposed Forest Head Quarters building will be constructed in the Forest Department land situated at Velachery Main Road, Velachery in two blocks of 4 floors each with the following specification at total rough estimate cost of Rs.30 Crore:-

The Principal Chief Conservator of Forests has also furnished rough cost estimate approved by Engineer in Chief (Building) and Chief Engineer (Building) Public Works Department, floor plans, elevation of proposed building and informed that the cost of interior and furniture have not been included in the estimate. The Principal Chief Conservator of Forests has therefore requested to sanction necessary order for construction of the Forest Head Quarters building by the Public Works Department at Velachery at a cost of Rs.30 crore.

4. The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and accord Administrative sanction for a sum of Rs.30.00 crore (Rupees Thirty Crore only) towards construction of the Forest Head Quarters building at Velachery as per the specification mentioned in para 2 above by the Public Works Department. Further financial sanction of Rs.1.00 Crore (Rupees One crore only) is accorded for initiating/completing the preliminary Works related to the construction of the said Forest Head quarters. The Government shall provide/sanction the remaining amount to the Principal Chief Conservator of Forests on need basis only.

5. The amount sanctioned in para 4 above shall be debited under the following head of account:-

"4406 CAPITAL OUTLAY ON FORESTRY AND WILDLIFE -01
Forestry – 070 Communication and Building. state's Expenditure – JB
construction of Buildings -16 Major Works"

(DPC:4406 01 070 JB 1600)

6. Necessary funds of Rs.1.00 crore will be provided in Final Modified Appropriation 2018-2019 to meet the expenditure sanctioned in para 4 above. Pending provision of such funds, the Principal Chief Conservator of Forests of Forests is authorized to incur the expenditure. However, the above expenditure shall be brought to the notice of the Legislature by a Specific Inclusion in the Final Supplementary Estimates for the year 2018-2019. The Principal Chief Conservator of Forests is also directed to include the expenditure sanctioned above while sending the budget proposals for FMA 2018-19 and also send draft explanatory notes for inclusion of this expenditure in Supplementary Estimates 2018-19 to Finance (AHD&F/BG.I) Department at an appropriate time without fail.
