In the Government Order first cited, Government have sanctioned a sum of Rs.95.00 lakhs for establishing an Indoor Stadium in Tamil Nadu Forest Academy, Coimbatore and Gym Centre each at Tamil Nadu Forest College, Vaigai Dam and in Tamil Nadu Forest Academy, Coimbatore during the year 2017-2018.

2. I am to invite attention to Principal Chief Conservator of Forests (HoD) letter second cited wherein, the Principal Chief Conservator of Forests (HoD) has requested

the Government to issue revalidation orders for the amount of Rs.95.00 lakhs sanctioned in G.O.(Ms).No.06, Environment and Forests (FR.2-I) Department, Dated 24.01.2018 to carry out the works during the year 2018-2019.

3. In this connection, I am to state that a sum of Rs.10.00 lakh has been incurred during 2017-18. Hence, the expenditure is restricted by adjusting the above amount.

4. I am therefore directed to convey the authorisation to incur the expenditure of Rs.85.00 lakhs (Rupees eighty five lakhs only) being the unspent balance for the year 2017-18, out of 95.00 lakhs sanctioned in the reference first cited above for establishing an Indoor Stadium in Tamil Nadu Forest Academy and a Gym Centre each at Tamil Nadu Forest Academy, Coimbatore and Tamil Nadu Forest College, Vaigai Dam during 2018-19.

5. The Expenditure authorized in para 4 above shall be debited to the following head of Account:-
