Pending provision of such funds, the Principal Chief Conservator of Forests is authorized to incur the expenditure. However, the above expenditure shall be brought to the notice of the Legislature by a Specific Inclusion in the Supplementary Estimates for the year 2018-2019. The Principal Chief Conservator of Forests is also directed to include the expenditure authorized above while sending the budget proposals for Revised Estimates / Final Modified Appropriation 2018-2019 and also send draft explanatory notes for inclusion of this expenditure in Supplementary Estimates 2018-2019 to Finance (AHD&F/BG.I) Department at an appropriate time without fail.
