ORDER :

In the Government Order first read above, the Government have accorded administrative approval for a sum of Rs.30.00 lakhs for "Establishing a Medicinal Tree Park in Palani Town" for three years from 2017-2018 to 2019-2020 and also released a sum of Rs.26.64 lakhs for the year 2017-2018 for establishing the Medicinal Tree Park in Palani Town as detailed below:-

2017-2018	Rs.26.64 lakhs
2018-2019	Rs.2.09 lakhs
2019-2020	Rs.1.27 lakhs
Total	Rs.30.00 lakhs

2. In the letter second read above, the Principal Chief Conservator of Forests has stated that the works sanctioned for the year 2017-2018 have been carried out by utilising the sanctioned amount of Rs.26.64 lakhs. As per the sanction accorded, an amount of Rs.2.09 lakh is required to carry out the maintenance work during 2018-2019. Therefore, he has requested to sanction a sum of Rs. 2.09 lakhs for maintenance works of the Medicinal Tree Park for the year 2018-2019.

3. The Government have carefully examined the above request of the Principal Chief Conservator of Forests and sanction a sum of Rs.2.09 lakhs [Rupees Two lakhs and nine thousands only] required to carryout the maintenance work for the year 2018-2019 for the Medicinal Tree Park established in Palani town.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

5. Necessary additional funds will be provided in Revised Estimate/Final Modified Appropriation 2018-2019. Pending provision of such funds in Revised Estimate/Final Modified Appropriation 2018-2019, the Principal Chief Conservator of Forests is authorized to incur the expenditure sanctioned in para 3 above. The Principal Chief Conservator of Forests is requested to send necessary proposals to Government in Finance (AHD&F) Department for inclusion of the above amount in Revised Estimate / Final Modified Appropriation 2018-19 at an appropriate time without fail.
