Sir,

Sub: Forests - Announcement - "Revitalization of Forestry Extension Services in 8 Forestry Extension Centres of Tamil Nadu" - Rs.375 lakhs sanctioned during 2017-2018 - Authorization to incur unspent amount of Rs.312.63 lakhs during 2018-2019 - Requested - Authorization - issued.

In the circumstances stated by the Principal Chief Conservator of Forests in his letter cited, I am directed to convey the authorization of the Government to incur an expenditure of Rs.312.63 lakhs (Rupees Three crores twelve lakhs and sixty three thousand only) being the unspent sanctioned in the Government Order first read above, during 2018-2019 towards the implementation of the scheme of "Revitalization of Forestry Extension Services in 8 Forestry Extension Centres of Tamil Nadu" i.e. Thenmathur in Thiruvannamalai district, Ulundurpet in Villupuram district, Arachalur in Erode district, Sidharkoil in Salem district, M.R.Palayam in Trichy district, Dindigul in Dindigul district, Pasumalai in Madurai district, and Ponnangudi in Tirunelveli district.

2. The expenditure authorized in para 1 above shall be debited to the following head of account:-

"4406 CAPITAL OUTLAY ON FORESTRY AND WILDLIFE - 01 Forestry. 101 Forest Conservation, Development and Regeneration - State's Expenditure AA. Revitalization of Forestry Extension Centres - 16 Major Works. (DPC: 4406 01 101 AA 1604)"

3. Necessary funds will be provided in Revised Estimates / Final Modified Appropriation 2018-2019 to meet the expenditure authorized in para 1 above. Pending provision of such funds, the Principal Chief Conservator of Forests is authorized to incur the expenditure. However, the above expenditure shall be brought to the notice of the Legislature by a Specific Inclusion in the Supplementary Estimates for the year 2018-2019. The Principal Chief Conservator of Forests is also directed to include the expenditure sanctioned above while sending the budget proposals for RE/FMA 2018-2019 and also send draft explanatory notes for inclusion of this expenditure in Supplementary Estimates 2018-2019 to Finance (AHD&F/BG.I) Department at an appropriate time without fail.
