ORDER:-

The Hon'ble Minister for Forests has made the following announcement on the floor of Legislative Assembly on 01.07.2019:-

“தமிழ்நாடு வனத்துறையில் முன்நிலை பணியாளர்களாக பணியாற்றி வரும் வனச்சரக அலுவலர்கள், வனவர்கள், வனக்காப்பாளர்கள் மற்றும் வனக்காவலர் குடியிருப்புகளுக்கு மூன்று வருடங்களில் வருடத்திற்கு 10.00 கோடி ரூபாய் வீதம் மொத்தம் 30.00 கோடி ரூபாய் நிதியில் சிறப்பு பராமரிப்பு மற்றும் மேம்பாட்டுப் பணிகள் மேற்கொள்ளப்படும். 2019-20 ஆம் ஆண்டிற்கு 10.00 கோடி ரூபாய் செலவில் பராமரிப்பு பணிகள் மேற்கொள்ளப்படும்.”

2. The Principal Chief Conservator of Forests in the letter read above has stated that the valuable forest wealth is being protected by the Frontline staff of Forest Department. There are 2540 numbers of Staff quarters available in Forest Department. Most of the staff quarters were constructed in remote and rural areas so as to protect the forest and wildlife. Almost more than 50% of the quarters are not in good condition since these quarters were constructed some decades ago. Minor repairs have only been done in certain buildings by utilizing the funds allotted under non-plan every year. Still basic works such as water supply, sanitation, electrical and patch works have to be done in most of the quarters.

3. He has also furnished the number of staff quarters proposed to be improved in 3 years and the amount required as follows:-

2020-21	207	Rs.10.00
2021-22	210	Rs.10.00

4. The Principal Chief Conservator of Forests has therefore requested the Government to sanction a sum of Rs.30.00 crore (Rupees Thirty Crores only) for Special repairs and improvement of frontline staff quarters for three years (i.e 2019-2020 to 2021-2022) and to release a sum of Rs.10.00 crore to carry out the works during the year 2019-2020.

5. The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and accord administrative sanction for a sum of Rs.30.00 crore (Rupees thirty crore only) for carrying out Special repairs and improvement of frontline staff quarters of Forest Department during 2019-2020 to 2021-2022.
