ORDER :

In the Government Order first read above, the Government have accorded administrative sanction for a sum of Rs.2.50 crore for carrying out Eco restoration works in Nanmangalam Reserved Forests area of 18 Hectare by undertaking high density planting for improving Biodiversity and for creating green lungs in and around Chennai over a period of five years from 2018-2019 to 2022-2023 as detailed below and also sanctioned a sum of Rs.80.74 lakh for implementation of the above scheme during the year 2018-2019 :-

2. The Principal Chief Conservator of Forests in his letter second read above has requested the Government to sanction a sum of Rs.97.68 lakh for the year 2019-2020, as per the administrative sanction accorded in the Government Order read above, for planting of taller and smaller seedlings towards the Eco restoration of Nanmangalam Reserved Forests area of 18 Hectare. He has furnished the works to be carried out during the year 2019-2020 as detailed below :-

3. The Government after careful consideration of the proposal of the Principal Chief Conservator of Forests have decided to accept and sanction a sum of Rs.97.68 lakh (Rupees Ninety Seven Lakh and Sixty Eight Thousand only) for planting of taller and smaller seedlings towards the Eco restoration of Nanmangalam Reserved Forests area of 18 Hectare, for the year 2019-2020.

4. The expenditure sanctioned in para 3 above may be debited to the following head of account:-

5. Necessary funds Rs.97.68 lakh will be provided in Revised Estimates/Final Modified Appropriation 2019-2020 to meet the expenditure sanctioned/released in para 3 above. Pending provision of such funds, the Principal Chief Conservator of Forests is authorized to incur the expenditure. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2019-2020. The Principal Chief Conservator of Forests is also directed to include the expenditure

sanctioned above while sending the budget proposals for RE/FMA 2019-2020 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Finance (AHD&F/BG.I) Department at an appropriate time without fail.
