ORDER:-

In the Government Order first read above, the Government have sanctioned an amount of Rs.50.00 lakhs (Rupees fifty lakhs only) for creation of Forest Elite Force as in Tamil Nadu Forest Department at two places (i.e.) Vaigai Dam, Theni and Coimbatore.

2. In the letter second read above, the Principal Chief Conservator of Forests has stated that as per the Government Order first read above, an amount of Rs.50.00 lakhs was sanctioned for the year 2018-2019 for creation of Elite Force. A sum of Rs.34.936 lakhs was incurred during the Financial year 2018-2019. The details of the expenditure for the amount of the Rs.50.00 lakhs are as follows:-

3. The Principal Chief Conservator of Forests (Head of Department) has now requested the Government to revalidate the balance amount of Rs.15.064 lakhs to carry out the pending works during 2019-2020.

4. The Government have carefully examined the proposal of the Principal Chief Conservator of Forests and decided to accord to sanction an amount of Rs.15.064 lakhs (Rupees Fifteen lakh and six thousand and four hundred only) to carry out the pending works under Forest Elite Force as in Tamil Nadu Forest Department during the year 2019-2020.


