### **ORDER :**

The Hon'ble Minister for Forests while moving the Demand for Forest Department on 1.7.2019, has made the following announcement :-

“வளர்ந்து வரும் நகரங்கள் மற்றும் நகர்ப்புறங்களில் இழந்த பன்முகத்தன்மையை மீட்டெடுக்கும் விதமாக அரிதான மற்றும் அழியும் தருவாயில் உள்ள உயிரினங்கள், தாவரங்களை பாதுகாக்கும் வகையில் திண்டுக்கல் மாவட்டம் சிறுமலையில் 5 கோடி ரூபாய் திட்ட மதிப்பீட்டில் மூன்றாண்டுகளில் பல்லுயிர் பூங்கா அமைக்கப்படும்”.

2. Based on the above announcement, orders have been issued in the Government order second read above according administrative approval for a sum of Rs.5.00 crores for implementing the scheme of “Establishment of Biodiversity Park at Sirumalai, Dindigul District” for a period of 3 years from 2019-2020 to 2021-2022.

3. The Principal Chief Conservator of Forests in his letter first read above among other things has furnished the cost table for the establishment of the said Biodiversity Park for the year 2019-2020 and requested to sanction a sum of Rs.2,43,00,000/- during the year 2019-2020.

4. The Government after careful examination, accept the proposal of the Principal Chief Conservator of Forests by restricting the amount of certain items whose cost estimate are high and accord financial sanction for a sum of Rs.2,05,12,500/- (Rupees two crore five lakh twelve thousand and five hundred only) for the year 2019-2020 for the Establishment of Biodiversity Park at Sirumalai, Dindigul as per the table annexed to this order.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

6. The Principal Chief Conservator of Forests is the estimating, reconciling and controlling authority of the above new head of account.

7. The expenditure sanctioned in para 4 above shall constitute an item of "New Service" and the approval of the Legislative shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2019-2020. Pending approval of the Legislature, the expenditure shall initially be met by drawl of an advance from the Contingency Fund. Orders regarding this will be issued by the Finance (BG-I) Department separately. The Principal Chief Conservator of Forests shall apply to the Government in Finance (BG.I) Department in prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. The Principal Chief Conservator of Forests shall also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2019-2020, without fail.
