ORDER:

Based on the announcement of the Hon'ble Chief Minister under rule 110, of Tamil Nadu Legislative Assembly Rules in the Government Order first read above, the Government have accorded, administrative sanction for a sum of Rs.30.00 crore towards construction of the Forest Head Quarters building at Velacherry and further release a sum of Rs.1.00 crore for initiating/completing the preliminary works related to the construction of the said Forest Head Quarters.

2. In the letter second read above, the Principal Chief Conservator of Forests has stated that as per the said Government order 1st read above, the construction work of Forest Head Quarters was entrusted to Public Works Department. The foundation stone was laid by the Hon'ble Chief Minister and the work has commenced on 01.03.2019. Out of Rs.1.00 crore released for the preliminary works, Rs.99.56 lakh has been incurred as expenditure by the Public Works Department during 2018-2019 and he has informed that, the Engineer in Chief (Buildings), Public Works Department and Chief Engineer Buildings, Chennai Region, Chepauk has stated that based on the value of work done and the present stage of the work, it is possible to incur Rs.20.00 crore by this Financial year 2019-2020.

3. The Principal Chief Conservator of Forests has therefore requested for releasing an amount of Rs.20.00 crore (Rupees twenty crore only) for the construction of the forest head quarters building work during 2019-2020.

4. The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and release an amount of Rs. 20.00 crore (Rupees twenty crore only) towards construction of the Forest Head Quarters building work during 2019-2020. Subject to the condition that the allocation is fully utilized without surrender.

6. Necessary funds will be provided in RE/FMA 2019-2020. Pending provision of funds in RE/FMA-2019-2020, the Principal Chief Conservator of Forests is authorized to draw and utilize the amount sanctioned in para 4 above. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2019-2020. The Principal Chief Conservator of Forests is directed to include this item of expenditure while sending the proposal for RE/FMA 2019-2020 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Government in Finance (AHD&F/BG-I) Department without fail.
