ORDER:-

The Hon'ble Minister for Forests has made the following announcement on the floor of Legislative Assembly on 01.07.2019:-

“தமிழ்நாடு வன உயர் பயிற்சியகத்தின் உள்கட்டமைப்பினை நவீனப்படுத்தும் விதமாக புதிதாக 15 அறைகள் கொண்ட பெண்கள் விடுதி கோயம்புத்தூர் மற்றும் வைகை அணை பயிற்சி மையங்களில் கட்டுவதற்கும் வகுப்பறை, ஆய்வுகூடம், கணினி அறை, நூலகம், கலையரங்கம், அருங்காட்சியகம் அமைப்பதற்கும் புதிய குடியிருப்புகள் கட்டவும், ஏற்கனவே உள்ள குடியிருப்புகளை பராமரித்து புதுப்பிக்கவும் மற்றும் வாகனங்கள் வாங்குவதற்கும் 15.74 கோடி ரூபாய் மதிப்பீட்டில் பணிகள் 2019-2020 ஆம் ஆண்டில் மேற்கொள்ளப்படும். ”

2. The Principal Chief Conservator of Forests in the letter read above has stated that the Tamil Nadu Forest Academy situated in Coimbatore is 107 years old. The Nationally renowned institution is the premier training centre for training various categories of Forest Department staff including Indian Forest Service Officers, State Forest Service Officers, Uniform and Ministerial Staff. The institution which was established in 1912 is now providing induction training to the Forest Range Officers from various States. He has further stated that

the Tamil Nadu Forestry Training College, Vaigai Dam, Theni District which is a constituent institution of Tamil Nadu Forest Academy, Coimbatore started in the year 1962 and functioning as a sole institution for training the front line uniformed staff namely Forest Guards and Foresters.

3. He has further stated that it has been planned to upgrade the said institutions with the state of art infrastructural and training facilities. It has been proposed to improve and upgrade the infrastructures of existing main building, class rooms, laboratories, examination hall, computer lab, faculty room, playground, library, toilet facilities, trainees' hostel, drinking water facilities, executive hostel, existing quarters and construction of new quarters in Tamil Nadu Forest Academy, Coimbatore and Tamil Nadu Forestry Training College, Vaigai Dam at a cost of Rs.13.34 crore. He has further stated that since more than 30% of the newly recruited Foresters and Forest Guards are women, it has been proposed to construct 15 rooms exclusive women trainees hostel one each in Tamil Nadu Forest Academy, Coimbatore and Tamil Nadu Forestry Training College, Vaigai Dam at a cost of Rs.2.40 crore.

4. He has further given the break up details of cost involved for the said proposal as follows:-

The Principal Chief Conservator of Forests has therefore requested the Government to sanction a sum of Rs.15.74 crore to carryout maintenance, renovation and creation of new infrastructural facilities in Tamil Nadu Forest Academy Coimbatore and Tamil Nadu Training College, Vaigai Dam during the year 2019-2020.

6. The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and accord administrative sanction for a sum of Rs.15.74 crore (Rupees Fifteen Crore and Seventy Four lakh only) to carryout maintenance, renovation and

creation of new infrastructural facilities in Tamil Nadu Forest Academy Coimbatore and Tamil Nadu Training College, Vaigai Dam during the year 2019-2020.
