Forests - Announcements - 2019-2020 made in the Legislative Assembly on 01.07.2019 by the Hon'ble Minister for Forests - Establishment of Biodiversity Park at Sirumalai, Dindigul for a period of three years from 2019-20 to 2021-22 - Administrative sanction accorded - Sanction of unspent amount Rs.168.510 lakh pertaining to 2019-2020 and sanction of Rs.190 lakhs pertaining to 2020-2021 - orders issued

ORDER :

The Hon'ble Minister for Forests while moving the Demand for Forest Department on 1.7.2019 has made the following announcement :-

“வளர்ந்து வரும் நகரங்கள் மற்றும் நகர்ப்புறங்களில் இழந்த பன்முகத்தன்மையை மீட்டெடுக்கும் விதமாக அரிதான மற்றும் அழியும் தருவாயில் உள்ள உயிரினங்கள், தாவரங்களை பாதுகாக்கும் வகையில் திண்டுக்கல் மாவட்டம் சிறுமலையில் 5 கோடி ரூபாய் திட்ட மதிப்பீட்டில் மூன்றாண்டுகளில் பல்லுயிர் பூங்கா அமைக்கப்படும்.”.

2. Accordingly in the Government order first read above, administrative sanction was accorded for a sum of Rs.5.00 crores for implementation of the scheme “**Establishment of Biodiversity park at Sirumalai, Dindigul District**” to be implemented over a period of three years from 2019-20 to 2021-22 as detailed below:-

3. In the Government order second read above, a sum of Rs. 2,05,12,500/- was released during 2019-20 for the said scheme.

4. The Principal Chief Conservator of Forests in his letter third read above has stated that out of the amount of Rs. 2,05,12,500/- sanctioned during 2019-20, only a sum of Rs. 36.615 lakh was spent during 2019-20 and requested to revalidate the unspent amount of Rs. 168.510 lakhs to carry out the balance works during 2020-21 . He has also requested to sanction an amount of Rs. 190 lakhs pertaining to 2020-21 also to implement the scheme during 2020-21, as follows:-

Revalidation of unspent balance pertaining to 2019-20 (Rs. 2,05,12,500 – Rs.36,61,500)	:	168.510 lakhs
Sanction to implement the scheme during 2020-21		190.000 lakhs

5. The Government after careful examination, accept the proposal of the Principal Chief Conservator of Forests and authorize a sum of Rs.168.510 lakhs (Rupees One crore sixty eight lakh fifty one thousand only) pertaining to the year 2019-2020 to carry out the balance works during 2020-21 and also to sanction an amount of Rs.190 lakhs (Rupees One crore ninety lakh only) pertaining to 2020-21 to implement the scheme "**Establishment of Biodiversity park at Sirumalai, Dindigul District**" during 2020-21 as per the table annexed to this order.

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account :-

4406 - Capital Outlay on Forest and Wildlife - 01 - Forestry - 101 - Forest Conservation, Development and Regeneration - State's Expenditure - JO - Establishment of Biodiversity Park 416 - Major Works - 01 - Major Works.
(Old DPC: 4406 - 01 - 101 - JO - 1607)
(IFHRMS DPC: 4406 - 01 - 101 - JO - 41601)

7. Necessary additional funds of Rs.3,58,51,000/- will be provided in RE/FMA 2020-2021. Pending provision of such funds in RE/FMA 2020-2021, the Principal Chief Conservator of Forests is authorized to draw and disburse the amount sanctioned in para 5 above. However, this expenditure shall be brought to the notice of Legislature by Specific Inclusion in the Supplementary Estimate 2020-2021. The Principal Chief Conservator of Forests is directed to

include this item of expenditure while sending the proposal for RE/FMA 2020-2021 and also send draft explanatory note for inclusion of the expenditure in the Supplementary Estimate to Government in Finance (AHD&F / BG-I) Department without fail.
