3. Necessary additional funds of Rs.5,00,000/- (Rupees Five lakh only) will be provided in Revised Estimate / Final Modified Appropriation 2020-2021. Pending provision of such funds, the Principal Chief Conservator of Forests (HoD) is authorized to incur the expenditure sanctioned in para 1 above. The Principal Chief Conservator of Forests is also directed to include this expenditure, while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2020-2021.
