ORDER:

The Hon'ble Chief Minister has made the following announcement on the floor of Legislative Assembly on 13.03.2020, under Tamil Nadu Legislative Assembly Rule 110 as follows:-

5. The amount sanctioned in para 4 above shall be debited under the following head of account:-

"4406 CAPITAL OUTLAY ON FORESTRY AND WILDLIFE - 01 Forestry - 070 Communication and Building - State's Expenditure - JB construction of Buildings - 416 Major Works-01 Major Works"
