INSTRUCTIONS TO THE CANDIDATES APPEARING FOR CERTIFICATE VERIFICATION /
PHYSICAL STANDARDS VERIFICATION FOR THE POST(S) OF
FOREST GUARD / FOREST GUARD WITH DRIVING LICENCE

COVID - 19 Guidelines

Tamil Nadu Forest Uniformed Services Recruitment Committee will implement social distancing norms during the conduct of certificate verification in adherence to the Government of India guidelines in the present scenario of Covid-19 to ensure health and safety of the candidates. Appropriate precautionary measures have been taken by the Committee for fair and transparent conduct of the certificate verification without compromising on the safety of examiners and examinees. Candidates are required to adhere to the guidelines for social distancing and hygiene in their own interest. Non-adherence of social distancing norms and the following guidelines may lead to strict action against the erring candidate. The candidates are required to note and follow the following instructions:

1. In light of Covid-19 pandemic, the candidates are advised to reach the venue of examination well before gate closure time so as to avoid last minute crowding at the entry gate.
2. On reaching the venue, candidates are advised to follow social distancing norms and maintain distance of 6 feet between two candidates.
3. Facility for contactless hand sanitization will be available at entry gate and also inside the venue. All candidates are required to sanitize their hands.

4. Candidates with COVID-19 positive declaration or symptoms of fever, cough, etc. will not be permitted entry into the venue. Candidates will be checked with thermo guns at entry point for fever and candidates having above normal (>99.14° F/ 37.3o C) temperature will not be allowed entry. Provision of pulse oxymeter will also be available for COVID-19 screening.
5. Candidate may also use hand gloves at their discretion.
6. They will be required to put on surgical mask given by TNFUSRC.
7. Only candidates will be allowed entry inside the campus. In any case, accompanying persons will not be allowed entry.
- 8. Candidates should come with COVID-19 negative test result from a Government Hospital. The candidate should have undergone COVID-19 test 3 days prior to date of certificate verification.**

GENERAL

Candidates are requested to go through the following instructions carefully.

- 1) Candidates should produce two passport size photographs as uploaded in the application.
- 2) No further chance or change of date will be given for the above verification / test.
- 3) No Travelling Allowance / Dearness Allowance shall be given for this purpose.

A. CERTIFICATE VERIFICATION

- 1) Candidates are directed to be present along with a **copy of intimation (Email copy) and a copy of their online application** on the scheduled date and time at the venue without fail.
- 2) Candidates should produce the following **original certificates** along with **one set of self-attested copies**, in respect of all the claims made by them in their online application at the time of Certificate Verification.
- 3) The candidates are requested to arrange the certificates in the order as mentioned below:
 - i. Evidence for date of birth (S.S.L.C. / Government Gazette Notification)
 - ii. Community Certificate obtained from the Competent Authority as specified in para 11 (d) of the Information Brochure.
 - iii. If the candidate claims as Transgender (Third Gender) in the application, the candidate should produce a self-declaration and ID card issued by the Tamil Nadu Third gender Welfare Board as shown in the format in **Annexure - II** of the Information Brochure.

- iv. Evidence for educational qualification as on 30.11.2019 as mentioned in item 8 of the Notification.
- v. Evidence for possessing an adequate knowledge in Tamil viz., S.S.L.C / H.S.C / Degree (or) evidence for having passed the Second Class Language Test (Full Test) in Tamil conducted by TNPSC.
- vi. Candidates claiming reservation against outstanding Sportsperson quota should produce both the corresponding Certificate of Merit in original and also the related Form(s) obtained from the Competent authority concerned, as prescribed in **Annexure – III** of the Information Brochure (Please refer para 6.5 of Information Brochure).

Note:- If any candidate fails to produce the aforesaid Sports certificate and Form(s) in original at the time of Certificate Verification, their candidature for the reservation against outstanding Sportsperson will not be considered.

- vii. Candidates claiming for reservation as Person Studied in Tamil Medium (PSTM) in the application, should produce necessary certificate (in support of the claim that the candidate has studied the prescribed qualification in Tamil Medium) obtained from the competent authority concerned, as prescribed in **Annexure-IV** of the Information Brochure.
- viii. Candidates claiming for reservation as Destitute Widow in the application should produce a Certificate obtained from RDO / Sub-Collector / Assistant Collector.
- ix. Candidates claiming for reservation as Ex-Serviceman in the application should produce necessary certificate as prescribed in **Annexure – V** of the Information Brochure.
- x. Character and conduct Certificate obtained from the Head of the Institution in which the candidate has last studied / is studying, as the case may be. In the case of the candidate who has studied a course through correspondence, this fact should be stated along with necessary evidence. Such candidates should however produce a Character and Conduct Certificate from the institution where the candidate had undergone the regular course of study prior to the correspondence studies.
- xi. If the candidate is employed in Government service, a “No Objection Certificate” obtained from the appointing authority in the format as prescribed in **Annexure-VI** of the Information Brochure.

xii. In addition to the above, the following certificates have to be produced at the time of certificate verification for the post of **Forest Guard with Driving Licence**.

a) A valid Driving Licence issued by the Competent Transport Authority.

b) A certificate from a reputed Firm or Company to the effect that the candidate possesses experience in driving of Light motor vehicles/Heavy Motor Vehicles for a period of not less than three years after getting the driving Licence.

c) A self-declaration of the candidate stating that he possesses a basic knowledge about the general mechanism of automobiles.

d) A First-Aid certificate issued by the recognized organization in Tamil Nadu

e) A certificate from the District Government Headquarter Hospital about the following.

i. To possess the visual standard specified below without glasses.

	Right Eye	Left Eye
Distant Vision	6/6	6/6
Near Vision	0.5	0.5 (Snellen)

ii. Each eye must have full field of vision.

iii. Absence of Colour blindness, squint or any morbid condition of the eyes or lies of either eye

iv. Lasik / Laser Surgery/ Excimer Laser Surgery have not underwent by the candidate in either of the eye.

4) The provisional admission of the candidate for Certificate Verification **does not confer any rights for admission to Physical standards verification and Endurance test / selection to the post.**

5) **The Candidates are informed that the claims made in their online application are final at all stages. If their claims are found to be false or incorrect, their candidature will be liable for rejection. Subsequent claims regarding educational qualification / age / community / Other reservations etc. will not be entertained.**

- 6) The candidate's attention is drawn to para 13 of the Information Brochure and further informed that if the candidate involves in any act of indiscipline at the venue of Certificate Verification, it will be viewed seriously.

Note:- Before leaving the Certificate Verification centre, the candidates should confirm that all the original certificates furnished for verification have been received back by them after verification. The committee will not take any responsibility for the loss of any original certificates thereafter.

B. PHYSICAL STANDARDS VERIFICATION:

1. After Certificate verification, the eligible candidates will be admitted provisionally for Physical Standards Verification. An Identification Certificate will be issued to the candidate for attending the above Test.
2. The provisional admission of the candidate for the above test **does not confer any rights for admission to selection to the post.**
3. After verifying the identity of the candidate, **Physical standards verification** will be conducted as mentioned in item 10 of the Notification.
4. **The candidate is directed to be present for Physical standards verification in the same venue immediately after certificate verification.**
5. The candidate should produce the certificate at the time of Physical standards verification as mentioned in item 10 (ii) of the Notification (i.e. Certificate of Physical standards)

Note:- 1. **The Provisional Admission of the candidates for Certificate Verification / Physical standards verification is purely provisional subject to the outcome of the Writ Petitions / Cases, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.**

2. The candidate's attention is drawn to para 13 of the Information Brochure and further informed that if the candidate involves in any act of indiscipline at the venue of Certificate Verification/Physical Standards Verification it will be viewed seriously.
