Sanction is accorded for creation of a temporary post of Additional Principal Chief Conservator of Forests (Project Tiger) with headquarters at Coimbatore and a temporary post of Additional Principal Chief Conservator of Forests (CAMPA and Forest Settlement), Office of the Principal Chief Conservator of Forests at Chennai in the scale of pay of Rs.HAG + 67000 - 79000 under the proviso to rule 4(2) of the Indian Forest Service (Cadre) Rules, 1966.

2. The Government also direct that for creation of the above two temporary posts of Additional Principal Chief Conservator of Forests, the temporary post of Chief Conservator of Forests and Additional Director-II,

Tamil Nadu Forest Academy, Coimbatore sanctioned in Government order third read above be disbanded and the cadre post of Chief Conservator of Forests and Principal, Tamil Nadu Forestry Training College, Vaigai Dam sanctioned in the Government Order fourth read above be kept in abeyance from the date on which the two temporary additional posts of Additional Principal Chief Conservator of Forests are filled up.

3. The Government also direct that the cadre post of Conservator of Forests and Additional Director, Arignar Anna Zoological Park, Vandalur sanctioned in the Government Order fourth read above be redeployed to Tamil Nadu Forestry Training College, Vaigai Dam as Conservator of Forests and Principal.
