ABSTRACT

Forests – Registration of Saw Mills – Fixation of fees for registration and renewal of Saw Mills – Orders -Issued .

ORDER:

In the G.O. read above orders were issued framing the Tamil Nadu Regulation of Wood Based Industries Rules, 2010 and the same was notified in the Tamil Nadu Government Extra-ordinary Gazette (No.323), dated 21.10.2010.

2. The Principal Chief Conservator of Forests in his letter second read above has stated that as per Rule 4(1), person seeking licence shall pay such fee as may be specified by the Government from time to time, along with the application. Similarly, as per Rule 5(1), renewal of such licence has to be done after collection of such fee, as may be specified by the Government from time to time. Accordingly, the following fee structure is proposed under Rule 4(1) and 5(1) of the Tamil Nadu Wood Based Industries Rules, 2010 in respect of licence and renewal fee, taking into account the prevailing price of timber in the market.

1. Licence fee under Rule 4(1) :: Rs.5000/- (for the licence period of 5 years)
2. Renewal of licence fee under Rule 5(1) :: Rs.5000/- (for the renewal of licence for every further period of 5 years).

He has further stated that as per the Hon'ble Supreme Court of India, New Delhi orders and the Central Empowered Committee guidelines, the sawmills established prior to 30.10.2002 have to be regularized by issuing licence under said Rules. The Principal Chief Conservator of Forests has therefore requested Government orders for further action in this regard.

3) Government after careful examination, fix the following fees for registration and renewal of saw mills.

1. Licence fee under Rule 4(1) :: Rs.5000/- (for the licence period of 5 years)
2. Renewal of licence fee under Rule 5(1) :: Rs.5000/- (for the renewal of licence for every further period of 5 years).
